Recently the Committee have spent quite some time on budgeting for the coming year. This has required considerable work by our Treasurer, Simon Carter, Bookkeeper, Helen Sharrock, Secretary, Ken Mann and budget holders, in particular, Building & Grounds Manager, Ron Mason, John Maher and Anita Hunter on behalf of the Sailing Committee and Sailing School.

In this process, we have taken into consideration, the continuing upgrade to facilities e.g.: clubrooms; in particular the impending upgrade of our switchboard, which will meet GMW requirements, as do the RSD's on the power poles in the caravan park.

Our outdoor kitchen has been progressing nicely of late, many members have given up their spare time over a number of weekends to get the building completed before the winter sets in with all that rain, hopefully. I did hear a report that April rainfall was well over the average for recent times, however they state that the winter may not be as wet as we have seen this last month or so. Let us hope that they get that wrong.

Last month an anonymous survey was emailed to all members, asking a variety of questions with the opportunity to contribute feedback. We did not receive an overwhelming response, however those who did contribute, provided many comments that the committee can review and address in their coming term. The majority of feedback was positive, some very construction criticism that provides the committee with sufficient information to understand which areas are a priority to our members.

As we prepare for the Annual General Meeting this is my last report as Commodore. It has been an interesting experience; it certainly has made me aware of the many duties, restrictions and guidelines the Committee meet. They work very hard toward improving and building on our current reputation providing some of the best facilities, services and clubrooms in regional Victoria; as was recently commented to me, even better than some in the city.

I would like to thank the members of the Committee for their support during this past year. Without doubt, every member has the best interests of the club and their portfolio in mind in every decision.

Well, it's another enjoyable year down with a full lake and plenty of camaraderie. That's what I love about this club; not just the beautiful setting on the lake, the vista that greets you every time you arrive, or the changeable and challenging sailing conditions, but mainly the people. Let's hope the current trend continues.

It seems that with the lake levels improving, so does the vibrancy of the club. There have been a lot of great improvements made to the club's amenity this year thanks particularly to Commodore Andrea, and to Ron Mason and all the working bee participants for making it an even greater place to be. We have a terrific and stable base of long-term members who, like me, continue to enjoy the social and sailing aspects of the club. We also have a strong influx of new members and families interested and keen to pick up this sport and share in the fun. Welcome to all those new members and families. Enjoy.

Last year at this time we had 221 Members which was a steady decline from previous years. We have now turned a corner with 239 financial members. Of these, there are:

Vale ~ Shirlee & Alan Hudson

It is with much sadness that Bendigo Yacht Club notes the recent passing of two of our long time members, Shirlee & Alan Hudson, both in their 94th year, and within 3 weeks of each other.

In about 1970 Shirlee and Alan moved from Mildura to Bendigo where Alan, not finding golf to his liking, took up sailing a Quickcat. A very friendly and club orientated couple they became heavily involved with the club. Shirlee was a member of the inaugural Ladies Committee. The Canteen, the Catering committee and in the Control Room were just a few areas where Shirlee's expertise were seen. Being an ex-nurse, the First Aid Kit was always well stocked with Shirlee around. In fact the original First Aid Kit that Shirlee set up (a World War 2 relic) is still at the club somewhere. She and Alan always took an avid interest in watching the development of the club's junior sailors.

Alan became Commodore in 1975/76 and again in 1976/77 and he was made a Life Member of the club in 1983. He championed the introduction of a sternchaser race and felt that if the handicapping was done correctly it would give everyone a fair chance and the Hudson Handicap sternchaser trophy has been provided by them each year.

Many years ago, for health reasons the Hudson's moved to the beautiful, and warmer area of Port Stephens NSW, first to Corvette and then to a retirement village in Fingal Bay. They became involved in the community and Alan become a member of the Port Stephens Coast Guard where he won an OAM for his work with this voluntary organisation.

They kept in contact with Bendigo Yacht Club through the many friends they had made during their time with the club and of course with their monthly edition of Mainsheet.

Our thoughts and condolences go Shirlee and Alan's family and friends.

Buildings and Grounds

May 2017

There has been a lot happening on the buildings and grounds front lately.

The electricians have upgraded the caravan park power posts that service the vans which ensures that the vans have the most up to date protection. They tested and tagged the van power leads as well, this was a requirement of the GMW annual audit. The next job for the electricians is the much needed upgrade to the main meter box. This upgrade will include the replacement of the old meter box and fuses and replacing with approved fuses and residual current devices. This will bring the clubhouse into line with current safety standards and protect the members from electric shock due to faulty electrical equipment or accidental damage. The upgrade is programmed for completion within the next few weeks.

Currently we are working on the outdoor kitchen which is the first stage of the clubhouse refurbishment. After completion of the outdoor kitchen we will gut the current kitchen annex and turn it into a disabled toilet. Once the disabled toilet is complete we will turn our attention to the upgrades to the male and female toilets. Somewhere among those projects we would also like to address the placing of a deck area outside the common room.

These projects will not only lift the ambience of and improve the facilities of the club for our current members but will help us increase and retain our membership base.

None of the work completed thus far would have been possible without the tremendous support from our members at our working bees. The working bees have been very well attended, and very well catered for by Marg Grant and her team, I personally thank you all for your fantastic effort.

The plans of the refurbishment are available on our website and I encourage all members to have a look at them to familiarize themselves with the planned improvements. 5. Sailing Instructions

7. Courses

The course to be sailed will be detailed in the Sailing Instructions.

8. Scoring System

A minimum of 3 races are required to be completed to constitute a series.

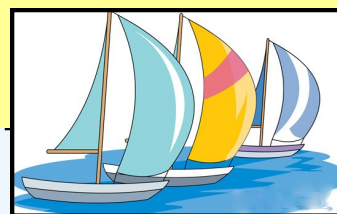

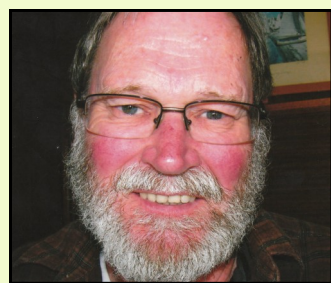

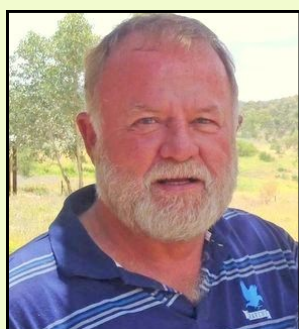
